**Distinguished Teaching**  
**2007- 2008**

**History:**

The Lindback Award was established by the Christian R. and Mary F. Lindback Foundation in 1960. Christian R. Lindback was the founder of Abbots Dairies in Philadelphia. Mr. Lindback believed teaching to be a special talent and had great admiration for teachers in general. The first institution of higher education to award the Lindback was the University of Pennsylvania. Since its inception, most universities and colleges have given the Lindback Award to a teacher who exemplifies teaching excellence.

**Guidelines:**

When nominating a teacher for the Lindback Award, the following areas must be acknowledged: teaching, scholarship, contribution to the college, participation in the academic life of the college and advancement of the mission of the college.

**Who may be nominated?** Any full-time faculty member

**Who may nominate?** Any student, staff, faculty or administration member
