## **BUSINESS:**

1. Chairman of the Board, Randall A. New, having declared a quorum to be present, called the meeting to order.

- 2. Mr. New presented a proclamation to Mrs. Carolyn Roberts in memory of the service of her husband, Mr. Benjamin Ray Roberts, Jr., to Georgia Military College and as an advisory member to the Board of Trustees.

Mr. Martinez seconded the motion, and the motion was approved by unanimous vote. Mr. Martinez made the motion to approve the Junior College tuition and fees for all campuses as presented. Mr. Hogan

- 12. Mr. Bruce Dempster reported that the Executive Board of the Alumni Association met on April 6. He also reported that the 2002 Alumni Weekend has been scheduled for October 25-27, 2002.

## 13. PRESIDENT'S REPORT

General Boylan reported on plans for leasing additional space at the Valdosta, Martinez, and Union City campuses.

General Boylan reported that the \$13.4 million appropriated by the State for the construction of the new academic building has been approved by the Governor. Lord, Aeck, Sargent Architecture has submitted a plan for deferring items from the original plans which will allow the college to proceed with construction this fall.

General Boylan reported that the state legislation that was introduced during the legislative session to administratively assign Georgia Military College to the Georgia Department of Defense did not leave committee. He will pursue legislation during the next session to administratively assign Georgia Military College to the Board of Regents.

General Boylan received approval last month from the Governor's Commission to borrow \$7 million for the construction of a new barracks. He will request approval for obtaining a loan from the Board at the July meeting.

General Boylan stated that Mr. Larry Peevy has been employed as Vice President for Enrollment Management, to be effective August 1, 2002.
