



### 2023 - 2024 Georgia College Completion Grant Application

The Georgia College Completion Grant Program provides grant aid to assist eligible students who are within 80% of earning their degree and have an outstanding balance of direct costs at their eligible postsecondary institution. Eligible students may receive a lifetime award of up to \$2,500, depending on the extent of their outstanding balance of Direct Costs. Recipients must be enrolled in an undergraduate degree program and must be meeting all other eligibility requirements. **Awarding is based on funds available from the state.**

**Eligibility:**

- Must have a current FAFSA on file with GSFC/GAFutures and Georgia Military College.
  - Verification, if selected, must be complete. (Does not have to be Pell eligible)
- Must have a GSFAApp on file and be eligible for state funds
- Must meet SAP requirements
- Must have completed at least eighty (80) percent of credit requirements for graduation from your enrolled eligible program of study
  - Program completion is calculated by the completed hours **for the program** divided by the number of hours needed to complete the program
  - If multiple degrees, must have completed 80% for each program
- Owe Georgia Military an outstanding balance of **direct costs\*** for the current term, or term requesting the award.
  - *The outstanding balance is calculated after all other financial aid, including grants, scholarships, and loans, have been transmitted to the account (this also includes fees paid out of pocket)*
- The lifetime award for students is \$2,500.
- Cannot be issued a refund from the Georgia College Completion Grant.

**\*Direct costs** - educational costs that are institutional charges incurred by the student and must be paid directly to the postsecondary institution. Educational costs considered direct costs vary at institutions, but may include, but is not limited to, tuition and fees (mandatory and/or course related), books and supplies, living expenses, meal plans, etc. The charges or fines incurred due to actions by a student such as parking tickets, library fines, or late fees are not considered direct educational costs.
