BUSINESS:

- 1. Chairman of the Board, Mr. George Hogan, Sr., having declared a quorum to be present, called the meeting to order.
- 2. Chairman Hogan asked for a motion for the agenda to be adopted as presented. Mrs. Cook made the motion with Mr. Snider seconding the motion. The agenda was adopted by unanimous vote. All present Advisory Members unanimously voted as well.
- 3. General Caldwell, GMC President, gave a brief update to the Board on our upcoming annual fundraiser, All Paws In, and projected numbers for Main Campus graduation next month. The Board was reminded that this marks the 6th Annual All Paws In 24-hour fundraising campaign and it will take place on Monday, May 5th, supporting key legacy endowments across GMC. The Board was encouraged to participate to help reach the goal of 100% Board giving (currently at 81.9%), which is critical for advocacy and grant efforts.
 - General Caldwell also shared an update on graduation numbers for Main Campus. 223 students have already applied to graduate, with 151 expected to participate in the ceremony. Attendance will likely increase as the event approaches.
- 4. Chairman Hogan announced to the Board that the required 14-day public review period of our sole finalist for the position of the 22nd President of Georgia Military College was now complete. He then asked for a motion to approve Major General Terrence McKenrick, USA (Ret) as the selection for the 22nd President of Georgia Military College. Mr. Snider made the motion with Mr. Cobb seconding the motion. General McKenrick was approved as the 22nd President of Georgia Military College by unanimous vote. All present Advisory Members unanimously voted as well.
 - Major General McKenrick thanked the Board of Trustees for their trust and confidence. He relayed that he is excited to serve the students, faculty, staff, Alumni, Foundation, and the Milledgeville community as the 22nd President of Georgia Military College. General McKenrick also thanked General Caldwell for his tremendous leadership as President for the past 12 years.
- 5. Chairman Hogan thanked the Board of Trustees, the Presidential Search Committee, and all of the dedicated faculty and staff who supported the Presidential Search process. He expressed his sincere gratitude to everyone for their thoughtful deliberation and commitment throughout this important process.
 - Chairman Hogan also expressed his deep gratitude to General Caldwell for his exceptional leadership and steadfast dedication as the 21st President of Georgia Military College. He acknowledged the strong foundation

General Caldwell has established and credited his forward-thinking vision for shaping a bright future for the institution. Thanks to his leadership, generations of GMC cadets will benefit from the enduring impact of his service.
